NutriDyn D3 5000 is a highly bioavailable form of vitamin D3 (cholecalciferol), providing 5000 IU per softgel. Vitamin D is a micronutrient with rather ubiquitous actions in the body. Examples of vitamin D's myriad functions in the body include supporting stress levels, bone health, skin health, heart health, and immune function.<sup>41</sup>

Much of the vitamin D we obtain comes from direct exposure to sunlight, and spending a significant amount of time indoors (and away from sunlight) can lead to low levels of vitamin D in the body. Vitamin D is a term that refers to a group of five fat-soluble vitamins that are classified as secosteroids, with research suggesting vitamin D3 (cholecalciferol) as the most important form in humans.<sup>2</sup> Since we produce much of our natural vitamin D transdermally (through the skin) via sunlight exposure, it is imperative that oral supplementation of vitamin D comes in the form of D3; this is the most bioavailable form of vitamin D in a softgel, maximizing its absorption into the body.<sup>43</sup>

Technically speaking, vitamin D3 is structurally similar to cholesterol and is converted via the liver and kidneys to its active form, calcitriol. Calcitriol goes on to perform a multitude of roles in the body and is particularly crucial for proper absorption of the minerals calcium, iron, magnesium, phosphate, and zinc. Calcitriol also supports and promotes bone growth and regeneration, as well as immune, cardiac, and neuromuscular functions.<sup>+</sup>

It is crucial to obtain adequate amounts of vitamin D on a daily basis, as deficiency can lead to a host of health issues, including, but not limited to, rickets, Fanconi syndrome, autoimmune diseases, non-alcoholic fatty liver disease, and osteoporosis.<sup>44,5</sup>
